OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

ELIGIBILITY: The contest to win a Custom Tile Mosaic and an additional gift valued at an estimated \$3,000.00 selected by Perot Systems (the "Contest") is open to healthcare organizations domiciled in the United States at the time of entry who have received a letter from Perot Systems inviting them to participate.
